Pershore Riverside Centre CIO (charity no. 1156413) runs a small society lottery to raise funds to support our work with young people and families in and around Pershore, promoted on our website and in local media. Pershore Riverside Centre CIO (the promoter) is **Registered with Worcestershire Regulatory Services (WRS)** Reg Number: **Lic13/01179/LOTLIC**. Responsible person: Carol Draper, Pershore Riverside Centre, King George's Way, Pershore WR10 1QU, £5/ticket.

You must be 18 or over to enter. Entries not to be sold to or by anyone under 18 years of age.

Pershore Riverside Centre Monthly Lottery Rules

Entry to the Monthly Lottery is through a Registration form available from Pershore Riverside Centre or our website

1. By entering the Pershore Riverside Centre Lottery you agree to comply with these Rules, the rules and regulations of the Gambling Commission under legislation laid down in the Gambling Act 2005 and any further instructions or Rules issued by Pershore Riverside Centre CIO from time to time.
 2. Pershore Riverside Centre CIO may amend these Rules at any time and will notify you of any significant changes to these Rules and will publish the updated Rules on Pershore Riverside Centre's Website.
 3. Pershore Riverside Centre CIO may reject any application without giving reason at its absolute discretion if it has reasonable grounds to do so. No detail in the application may be changed in any way once it has been submitted, except for a change of address.
 4. You are solely responsible for providing and (where necessary) updating Pershore Riverside Centre CIO with your accurate and up-to-date contact details and the Pershore Riverside Centre Lottery will be in no way liable for any failure or inability to contact you due to any errors, omissions or inaccuracies in the contact details that you have provided.
 5. Pershore Riverside Centre CIO reserves the right to use winners' names for promotional purposes. These will only be used in summary eg Mrs Brown from Worcestershire.
 6. The cost of each entry is £5. You may purchase more than one entry.
 7. Payment must be made in advance before you can be entered into the draw. Only entries for which payment has been received in full are eligible to win a prize.
 8. You accept that we may be unable to provide refunds or replacements once you have purchased your lottery entries.

Proceeds

10. All proceeds from the Pershore Riverside Centre Lottery and occasional Raffles go to Pershore Riverside Centre CIO, which holds the funds in a separate account, to be used for the charitable Purposes of the organisation.

Eligibility to Enter

11. To enter the Pershore Riverside Centre Lottery you must be age 18 or over and live in the UK. We are not licensed to accept entries from The Channel Islands or The Isle of Man.
 12. You promise and confirm that you meet the Pershore Riverside Centre Lottery entry age requirements and are able in all legal respects to enter and participate in the Pershore Riverside Centre Lottery.

Conducting the Lottery and Prizes

13. Pershore Riverside Centre CIO will conduct the Pershore Riverside Centre Lottery on the 1st of each month (or next working day). The draw will be made utilising a Microsoft Excel Random Number Generator.
 14. The winning numbers will be published on Pershore Riverside Centre's website, published in *Pershore Times* and will be available from staff at Pershore Riverside Centre.
 15. The award and receipt by you of any Lottery Prize is subject to your compliance with these Rules.
 16. The prizes for Pershore Riverside Centre Lottery are printed in the leaflets provided and are advertised on Pershore Riverside Centre's website. There are no alternatives to any prize and no interest is payable. You will be notified as to any change in the prize structure. You must redeem your prize within three years of the original prize being awarded.
 17. Cash prizes will be sent by post and paid by cheque within 14 days. You must cash any cheques within six months of receipt.
 18. Pershore Riverside Centre CIO's decisions made pursuant to these Rules shall, once made, be final and binding.

Cancellation

19. You may cancel your subscription at any time by notifying us by phone, email, or in writing.
 20. Pershore Riverside Centre CIO reserves the right to:
 - i. decline to accept an application;
 - ii. cancel an existing subscription; and/or
 - iii. award any prize to an alternative winner if Pershore Riverside Centre CIO has grounds to believe that you have breached any of these terms and conditions, acted fraudulently or illegally, or on other reasonable grounds, and Pershore Riverside Centre CIO shall have no liability to you for any loss or damage you suffer arising from it exercising such rights.
 21. Pershore Riverside Centre CIO may (without giving any reason or notice) terminate suspend or modify the Pershore Riverside Centre Lottery.
 22. Any cancellation of an existing subscription will not affect your prior purchase of Pershore Riverside Centre Lottery's entries nor your rights as a holder of such entries, providing that you have complied with any applicable Rules in respect of such entries.

Complaints

23. Pershore Riverside Centre CIO operates a Complaints and Disputes Procedure, will be made available to you upon request.

Exclusions and Limitations

24. Nothing in these terms and conditions shall limit Pershore Riverside Centre CIO's liability for death or personal injury caused by its negligence, fraud or for any other matter for which liability may not be limited by law.
 25. Pershore Riverside Centre CIO is not liable to you for:
 - a. loss or damage, including the right to receive a prize, suffered by you if you have not complied with these rules, any relevant participation instructions or the rules and regulations of the Gambling Commission under legislation laid down in the Gambling Act 2005;
 - b. any delays or failures in the banking system used by you or Pershore Riverside Centre CIO,
 - c. the loss, theft, delayed receipt of or damage to any communication or entry,
 - d. Pershore Riverside Centre CIO's failure or inability to contact you and/or award any prize due to any errors omissions or inaccuracies in the contact or bank details you have provided or your failure to update these if they change,;
 - e. loss or damage incurred by you in connection with or arising from the use of Pershore Riverside Centre CIO's Lottery prizes or participation in Pershore Riverside Centre Lottery.

 27. All warranties, conditions or guarantees relating to the Pershore Riverside Centre Lottery made by or on behalf of Pershore Riverside Centre CIO whether express or implied by law, in the course of dealings or otherwise, are excluded to the maximum extent permitted by law.
 28. Pershore Riverside Centre CIO's liability to you shall be limited to the amount of any prize which has become due to you.
